



Mohegan Tribal Council Profiles



Kevin Brown “Red Eagle,” Chairman. Kevin Brown “Red Eagle” was elected Chairman of the Mohegan Tribe in October 2013 and is currently serving his second term. As Chairman, Brown is responsible for maintaining the sovereignty that the Mohegan Tribe fought hundreds of years for, overseeing its numerous business entities and ensuring the well-being of its more than 2,100 Tribal citizens. As Chairman, Brown also serves as Chairman of the Mohegan Gaming & Entertainment (MGE) Management Board which oversees gaming entities across the country, as well as two professional sports teams. Under his leadership, the Mohegan Tribe has made monumental steps forward in its business growth and expanded its footprint worldwide including the future Inspire Integrated Resort in South Korea and a multi-million-dollar non-gaming tourist destination in southeastern Connecticut, creating hundreds of jobs and driving economic growth in the region.

A native of Montville, Connecticut, Brown proudly served in the United States Army, retiring as a highly-decorated Colonel. His 25-year career includes extensive experience in strategic planning, combat leadership, and leading large military and civilian organizations while managing multimillion dollar budgets and forging international relationships.

Brown is a Doctoral Candidate in Security Studies from Kansas State University, and also earned a Master of Arts in Public Diplomacy from Norwich University, a Master of Science in Operations Research from the Naval Postgraduate School and a Bachelor of Science in Aerospace Engineering from the United States Military Academy at West Point.

Brown serves on the Board of Directors for the Chamber of Commerce of Eastern Connecticut and Channel 3 Kids Camp, and is the Chairman of the American Heart Association Southeastern Connecticut Heart Walk and the forthcoming National Native American Veterans Memorial at the Smithsonian's National Museum of the American Indian. He has been awarded the National Indian Gaming Association’s prestigious John Kieffer Sovereignty Award; both the Military Community Support Award and the Board of Directors Special Award from the Chamber of Commerce of Eastern Connecticut and the Annual Outstanding Leadership Award from the Boy Scouts of America.



James Gessner Jr., Vice Chairman. James Gessner Jr. is in his third term on the Tribal Council and served as Corresponding Secretary prior to becoming Vice Chairman. He is a member of the Audit Committee for the Mohegan Tribal Gaming Authority (MTGA). Gessner holds a bachelor’s degree in hotel and restaurant management from the University of Southwestern Louisiana, and prior to his terms on the Council he held

executive positions at Mohegan Sun in the Marketing and Player Development divisions. He resides in Waterford, Connecticut with his wife Carol and children Nicholas and Nola.



Cheryl A. Todd, Recording Secretary. Cheryl A. Todd was elected to the Tribal Council in 2007, after spending several years as Executive Assistant to the Tribal Chairman. Her experience in that position gained her a wide working knowledge of the Tribal government and Mohegan Sun. Outside the reservation, she was in touch with government officials at the federal, state, and local levels, and throughout the sovereign nations of Indian Country. Todd currently serves on the Connecticut Sun Foundation board and has also served on the Mohegan Strategic Planning Committee and the Mohegan Election Committee. Prior to her employment with the Tribe, Todd held multiple positions at the U.S. Naval Submarine Base in Groton, Connecticut.



Kathy Regan-Pyne, Corresponding Secretary. Kathy Regan-Pyne brings a wide-ranging professional background to her position, with experience in human resources management, budgeting and financial management, and marketing. She worked for several years in the insurance industry, holding management positions at both Lincoln Financial Group and CIGNA Property & Casualty. She has also worked as the Career Development Manager for the Mohegan Tribe. Regan-Pyne is a member of the MTGA Audit Committee, and is also currently on the board of the Connecticut Sun Foundation and Eastern Connecticut State University Foundation. She also holds a Bachelor of Science degree in Education from Eastern Connecticut State University. An avid sports fan and former professional basketball player, she is a member of the Connecticut Women's Basketball Hall of Fame and the New Britain Athletic Hall of Fame. She is a charter member of the Eastern Connecticut State University Athletic Hall of Fame. Regan-Pyne lives in Marlborough, Connecticut with her husband Roy.



Thayne D. Hutchins, Jr., Treasurer. Thayne D. Hutchins, Jr. has served on the Tribal Council since 2007. He is well prepared for his position as Treasurer, having worked for six years in the finance department of the Mohegan Tribe. As a staff accountant, Hutchins' business skills were employed in a variety of responsibilities, including the analysis and monitoring of the Tribe's many financial concerns. Hutchins graduated Magna Cum Laude from Eastern Connecticut State University, holding a B.A. in Economics with a concentration in accounting. He is a board member of SECTER (Southeastern Connecticut Enterprise Region) and also serves on the MTGA Audit Committee. Hutchins resides in Hampton, Connecticut with his wife Angela and children Madeleine and Thayne.



Mark F. Brown, Ambassador. Elected to the first Tribal Council following the Mohegan Tribe's federal recognition, Mark F. Brown has served continuously since 1995. A direct descendant of the renowned Mohegan Chief Matagha and the son of Tribal Nonner Pauline Brown, he was actively involved in the Mohegan Tribe's efforts to achieve federal recognition, leaving a career in law enforcement to devote himself full-time to the Mohegan people. Brown was Chairman of the Tribal Council from 2000-2005 at a time which saw the completion of the one billion dollar Project Sunburst expansion that made Mohegan Sun one of the world's top destination resorts. He currently serves on numerous boards both nationally and also in the local area, and serves as Chairman of the Mohegan Tribal Gaming Authority's Audit Committee. Brown is the proud father of three sons and resides in Montville with his wife Mary.



William Quidgeon Jr., Councilor. William Quidgeon, Jr. was first elected to the Tribal Council in 2005, and served as the Council's treasurer from 2005 to 2009. After relocating to Uncasville from New York State where he worked as a technician for Amtrak, Mr. Quidgeon initially held a management position for the Engineering Department of Mohegan Sun. He later became a Senior Project Manager for the Mohegan Tribal Development Department, where he was responsible for renovations and construction within the casino and for the Tribal government. He also served as the Board Chairman of Mohegan Information Technology Group, a limited liability company. Joseph Smith, Councilor. Joseph William Smith began his first term on the Tribal Council in October of 2015, following a decade of experience working for the Mohegan Tribe and Mohegan Sun. At Mohegan Sun, he worked in communications and publications, and later moved to a position as a publicist for the Sports and Entertainment department. For the Mohegan Tribe, he worked as a manager of communications and public affairs for eight years, responsible for internal and external outreach for the Tribe. Smith grew up in Uncasville, and later moved to both New York City and Los Angeles. Over a twenty-year career as a story editor and story analyst, he held positions at ABC, The Walt Disney Company, Paramount Pictures and 20th Century-Fox. He holds both Bachelor and Master of Fine Arts degrees from Columbia University, and lives in Middletown, Connecticut.
